Overview of the True-Up process (public and private)

The Ohio BWC uses estimated payroll to determine your premium and all employers are required to report actual payroll and pay additional premium (if due) by a deadline. Missing the deadline can cause you to be removed from rating programs and cost you savings. This short session will walk through the true-up process, identify reportable payroll and remind you of the deadlines. **This session is 30 minutes and does not qualify for the safety training requirement.**

How much is this going to cost me and what can I control? (public and private)

All Ohio state fund employers pay premium, but do you know how it is calculated? Or how to reduce your workers' comp spend? This session will review the elements that determine your annual premium including the factors that can increase and decrease your bottom line..
